Please Read Carefully**

We _____ and _____ are aware that membership in the Whitehorse Curling Club involves many RISKS AND DANGERS including BUT NOT LIMITED TO slipping and falling on ice or elsewhere, being bumped by other player(s) or moving stone(s) or tripping over objects fixed on the ice. We understand that known and unknown, foreseeable and unforeseeable, risks and dangers associated with on and off-ice activities associated with membership in the Whitehorse Curling Club may result in personal injury, full or partial disability, death, property damage or other loss.

In consideration of the Whitehorse Curling Club allowing my or my child's membership we agree, on behalf of ourselves, our heirs, assigns, personal representatives and next of kin, that:

1. WE UNDERSTAND, ASSUME AND ACCEPT, WITHOUT LIMITATION, ALL RISKS AND DANGERS associated with activities associated with membership in the Whitehorse Curling Club. We also understand the risks that may arise from the conditions and use of curling rinks and related premises and facilities and we acknowledge and understand that included within the scope of this waiver and release is any cause of action (including a cause of action based on negligence) arising from the performance, or failure to perform, maintenance, inspection, supervision or control of any curling rinks and related premises and facilities and for any failure to warn of any dangerous conditions existing and rinks, premises and facilities or for negligent supervision, negligent selection of persons involved in the all on or off ice activities, or for any other reason, whether known to me/us at this time, and whether or not reasonably foreseeable by me/us.
2. WE ASSUME FULL RESPONSIBILITY for understanding and following the rules and safe practices associated with curling and for our personal safety.
3. WE WAIVE, RELEASE AND RELINQUISH any and all claims for liability and causes of action, for any personal injury, property damage, or wrongful death against the Whitehorse Curling Club and its directors, officers, employees, agents and representatives (collectively referred to in this document as the "Whitehorse Curling Club") arising out of my or my child's participation in the activities of the Whitehorse Curling Club, whenever or however they occur including negligence on the part of Whitehorse Curling Club, participants or anyone else.
4. WE WILL INDEMNIFY AND HOLD HARMLESS the Whitehorse Curling Club from any and all liability for loss, damage, injury or expense suffered or incurred by me or anyone else in connection with my or my child's membership.

WE HAVE READ THIS DOCUMENT THOROUGHLY, and we shall not use ignorance of the above paragraphs as any cause or excuse to seek to recover for any liability on the part of any persons involved with the Whitehorse Curling Club. We agree that if we have any questions about this Waiver, we will ask the Whitehorse Curling Club for clarification prior to signing this Waiver. We understand that by signing this document we give up important legal rights including the right to sue. We understand that the Whitehorse Curling Club is relying on my full release and waiver of all claims when accepting my/our membership.
